Step-by-Step Instructions

The Wooden Window Repair Program (WWRP) application has been designed to help you complete the application process quickly and easily. The Connecticut Housing Investment Fund, Inc. (CHIF) administers the State of Connecticut Department of Economic and Community Development's Wooden Window Repair Program (WWRP). CHIF's Program Administrators are always available to assist with your application or to answer any questions you may have about the program. Information is also available on CHIF's website at www.chif.org. Contact information is provided below.

Follow the steps listed below to expedite the loan approval process.

Step 1:

Complete the "**Application for the Wooden Window Repair Program**" form. Please be sure to complete all sections and to sign the "Authorization to Release Information." CHIF reserves the right to charge a \$50.00 application fee (refundable if your application is approved) and a \$200.00 closing fee.

Step 2:

Please include the following documents with your application:

- Copies of work estimate from a licensed contractor or invoice or purchase order for windows with explanation of how installation will be completed.
- A lead paint abatement plan, if available.
- Verification of the age of the property. *Please note:* CHIF staff can assist you in obtaining the information.
- Verification that the applicant is current on all state and local taxes.
- Homeowners Insurance
- Articles of Organization for properties owned by a business.
- Proof of matching funds (Bank statement)

What are the criteria for the Wooden Window Repair Program?

1. The property must be a 2-6 rental building constructed before 1950
2. The property must be located in New Britain or Waterbury
3. Applicant must provide 100% matching funds for each window funded.
4. Applicants may obtain matching funds by using CHIF's Energy Conservation Loan Program or other eligible sources.
5. CHIF reserves the right to charge a \$50.00 application fee (refundable if your application is approved) and a \$200.00 closing fee.
